Principal's Report

1. Belinda B expressed heartfelt thanks from the P&C to the Principal, teachers and office staff for coping marvellously with the lockdown.
2. Onsite staff numbers have been cut to the minimum. Many deliveries are on hold including furniture.
3. COVID plan Year 12 graduation livestream cost around \$11,000 in 2020. Principal requested P&C consideration of support for the graduation. P&C usually contributes \$2,000.

Motion: To contribute \$8,000 for streaming of the Year 12 graduation in addition to \$2,000 for catering. Year 12 parents abstained from voting.
